

## **Application for Book Loan**

This book loan is for maximum \$500, including tax, and used only for the purchase of books and necessary supplies required for attending classes at Texas State Technical College.

#### **Student Requirements:**

- 1. Must have applied for Federal Financial Aid through FAFSA.gov
- 2. Must not have an outstanding balance owed to TSTC
- 3. Must be at least 18 years of age or parental signature required

### **Obligations and provisions:**

Section I: Borrower information

Any individual who falsifies information or fails to meet the payment requirements of this agreement will risk any or all of the following:

- 1. Being dropped from all classes at TSTC
- 2. Being turned over to a collection agency and reported to a credit agency
- 3. Withholding of grade credits, official transcripts, diplomas, and other benefits of the college

A student who fails to make full payment of book loan by the due date will be prohibited from registering for classes until full payment is made.
